The Promenade Shops at Clifton provides local specialty stores

Poag & McEwen Lifestyle Centers begins construction on 110,000 s/f in NJ

C LIFTON, NJ — Construction has begun on The Promenade Shops at Clifton with an opening planned for Fall 2008. The project is being developed by Poag & McEwen Lifestyle Centers, nationally known as the originator and premier developer of lifestyle centers, in partnership with The Briad Group, headquartered in Livingston.

The Promenade Shops at Clifton promises to be a truly unique shopping experience for the residents of densely populated Northern NJ. The center will be located on Rte. 3 and Allwood Road in Clifton, 1.5 miles east of the Garden State Pkwy. interchange. The 110,000 s/f lifestyle center will feature an appealing mix of national, regional and local retailers and restaurants in a beautiful open-air setting.

"With over 600,000 people residing within a 5 mile radius of the site, The Promenade Shops at Clifton will provide national and local specialty stores with tremendous access to the affluent, northern NJ market," said John Cirillo, VP, market research for Poag & McEwen.

"The mass of over 250,000 daytime workers within a fifteen to twenty minute drive offers restaurants an excellent opportunity to succeed."

Located only eleven miles west of Manhattan, the design of The Promenade Shops has been

inspired by NYC's metropolitan flavor. The Promenade Shops at Clifton is being developed in the high quality tradition of Poag & McEwen Lifestyle Centers, offering shoppers a convenient, safe, outdoor environment for shopping, dining, and gathering with neighbors. The site will be comprised of distinctive and elegant retail buildings surrounding a central plaza. This focal point, with its uniquely designed clock tower, shade structure, fountain, firepit, torchieres, and kiosks, will encourage pedestrian shoppers to linger and enjoy the street life.

The buildings will be set in an urban streetscape, with amenities such as benches, planters, street lamps, and cast-iron tree grates. The elevations are reminiscent of various buildings and storefronts along a NYC street, with varying heights and natural materials, creating an interesting cohesive composition. The high quality, of The Promenade Shops at

aesthetic materials that will be used are brick, stone, metal, and glass. Each tenant will provide awnings and/or canopies designed to further enhance the buildings' realism and appeal. Lighting and signage programs have been developed to promote a unified visual image.





